PENSIONERS DRAWING PENSION DIRECTLY FROM PAO COUNTER OF O/o THE PR. ACCOUNTANT GENERAL (A&E) ODISHA for SUBMISSION OF LIFE CERTIFICATE DIGITALLY through <https://jeevanpramaan.gov.in> portal.

As a Digital India initiative to facilitate pensioners, Ministry of Electronics & Information Technology (Meity) has launched jeevanpramaan (JP) Portal. Now, the pensioner need not visit office of the Pension Disbursing Agency (PDA) for physical submission of “Life Certificate” & may use the Aadhar enabled Biometric authentication mechanism to generate Digital Life Certificate(DLC).

Pensioners who are drawing their pension directly from PAO O/o the Pr. Accountant General (A&E)Odisha Bhubaneswar and submitting Life Certificate (November every year) by presenting themselves personally, may now avail the facility through the Jeevanpramaan Portal: <https://jeevanpramaan.gov.in> for generating Digital Life Certificate (DLC) which can be accessed by the pensioner & the PDA i.e Pay Accounts Officer as and when required by them to avoid hardships faced in this regard by the Pensioners amidst the present Covid-19 pandemic.

The Pensioners can either generate DLC themselves by downloading the jeevanpramaan application from the JP Portal : <https://jeevanpramaan.gov.in> /app/download & install client application on android based smart phones/tablet or Windows PC/ Laptop for DLC generation as per detailed instructions contained therein or it can also be done through the Citizen Service Centres (CSC). The all India list of such CSC & (name & address) in various states across India is posted on JP Portal at: <https://jeevanpramaan.gov.in> /locator.

The Pensioners/Family Pensioners who are drawing their monthly pension from PAO, Bhubaneswar and submitting Life Certificate can avail the DLC facility. At that time they have to select for **Pension Sanctioning Authority (PSA) as “Indian Audit & Accounts Department (IA&AD)”** and for **Pension Disbursing Authority (PDA) as “A.G. Office”**. For more information they can also access the (FAQ) for pension available in jeevanpramaan.

Now, for this year the Govt. of India, Ministry of Personnel, Public Grievances and Pension, Department of Pension & Pensioners’ Welfare vide OM No. 18/1/2020-P&PW(c)-6681 dt. 11.09.2020 has extended the period of submission of Life Certificate by the pensioner till 31.12.2020.
