**Sub: - Calling for application from fresh candidates of Revenue Audit (Main) Examination 2019**

In terms of Headquarters Office Examination Circular No 07 of 2019 issued vide No./402/09-Exam SAS/RA/CPD-I & II/Prog/Annual 2019 dated 24.04.2019 the Revenue Audit (Main) Examination will be held in all audit Offices. The dates of examination will be informed in due course.

**Eligibility Criteria for Revenue Audit Examination**

In terms of revised para 9.3.1.1 of Mso Admn( Vol.-I) eligibility criteria in respect of Sr.AO/AO/AOs for appearing Revenue Audit Examination is as under.

- a) Sr.AOs/AOs after having one year of continuous service in the Revenue Audit Branch as AAO/AO/Sr.AO or after having prescribed training in the Revenue Audit
- b) Departmental officials who are promoted as AAO are eligible for Revenue Audit Examination after completion of one year continuous service in Revenue Audit branch ; or have the prescribed training in Revenue Audit after completion of one year of regular service as AAO.
- c) The confirmed Directly Recruited AAOs are eligible to appear Revenue Audit Examination after completion of one year continuous service in Revenue Audit branch as a regular AAO; or have the prescribed training in Revenue Audit after completion of one year of regular service after confirmation as AAO.

Training will be arranged for the fresh RAE candidates during July-August,2019. Hence applications as per the enclosed proforma are invited from the eligible fresh candidates so as to reach the Trg.& Exam. Section (G&SSA), **on or before 10 July 2019**

Applications received in the Examination Section (G&SSA) after the above stipulated date will not be entertained under any circumstances. The candidates will have to register their candidature online for the above exam. The date of such registration will be intimated in due course. The unsuccessful/repeater candidates may apply immediately after declaration of Supplementary Examination ( June-2019)
