Sub: Calling for applications from fresh / repeater candidates intending to appear in Subordinate Audit/Accounts Service (SAS)/RA/CPD-I&II (Main) Examination to be held in November-2019

In terms of Headquarters office Circular No. 17 of 2019 issued vide No 810/14-Exam/Revised Syllabus/2018 dated 27.08.19, the above examinations are likely to be held in November-2019. The applications in the prescribed proforma (enclosed) are invited from eligible fresh / repeater candidates intending to appear SAS/RA/CPD-1&II (Main) examination - 2019. The applicants will have to register their names online like previous years, which will be notified in due course.

Eligibility criteria for Revenue Audit Examination

The eligibility criteria in respect of Sr. AOs/AOs/AAOs for appearing RA examination are as under

- i) Sr. AO/ AO/AAO after having one year of continuous service in the Revenue Audit Branch as AAO/AO/Sr.AO or after having prescribed training in Revenue Audit;
- Departmental Officials who are promoted as AAO are eligible to appear in Revenue Audit Examination after completion of one year of continuous service in Revenue Audit Branch; or have the prescribed training in Revenue Audit after completion of one year of continuous service as AAO.
- Confirmed Directly Recruited AAOs are eligible to appear in Revenue Audit Examination after completion of one year of regular service in Revenue Audit Branch as a regular AAO: or have the prescribed training on Revenue Audit after completion of one year of regular service after confirmation as ΛΛΟ.

Eligibility criteria for CPD-I Examinations

All Sr. AOs/AOs shall be eligible to take the CPD-I Test. AAOs including AAOs (Regular Temporary) shall be eligible to appear in the CPD-I test after completion of **four years** continuous service in the grade as on 01-Sep-2019.

Eligibility criteria for CPD-II Examinations

CPD-II Examination can be taken by Sr.AO/AO/AAOs after lapse of four years from qualifying their CPD-I Test. The CPD-II (Main) Examination 2019 can be negotiated by such officers who have qualified the CPD-I (Main) examination 2015 or earlier.
